### 1. Introduction

I, **[Participant's Full Name]**, hereby agree to participate in a Landscape Photography Workshop or Tour (the "Workshop") organised by First Man Ltd (the "Company"). I understand that the Workshop involves learning photography, hiking in the mountains, woodland, countryside, and/or coast, and using photographic equipment to capture images. I acknowledge that this waiver applies to all Workshops conducted by First Man Ltd that I attend.

### 2. Acknowledgement of Risks

I acknowledge and fully understand that participating in the Workshop involves inherent risks, including but not limited to those outlined in the **Workshop Risks Document** provided by the Company. I confirm that I have read and understood the Workshop Risks Document, which includes, but is not limited to:

- Damage to equipment; equipment misuse or failure
- Injury to other participants, members of the public, or the workshop leader
- Hypothermia; drowning; exhaustion and dehydration; heatstroke and sunburn
- Illness and poisoning, including heart attack, insect and animal bites
- Slips, trips, sprains, dislocations, and blisters
- Extreme weather conditions (flooding, high winds, lightning)
- Challenging terrain and locations; loss of mobile communication signal
- Strangulation or injury from loose clothing and jewellery (e.g., rings, necklaces, camera straps) and sharp objects
- Falling from height; rock fall; separation from the group
- Eye injury (sun and high winds); insect bites; encounters with animals; crush injuries

I understand that this list is not exhaustive, and other risks and dangers may arise.

## 3. Health and Fitness Declaration

I confirm that:

- I am fit and well, in good health, and capable of walking all day.
- I can hike up to **900 metres** of ascent and walk on uneven and loose terrain.
- I have suitable experience and appropriate outdoor clothing for such activities, as detailed in the **Workshop Customer Information Sheet**, which I have read and understood.
- I have no known medical conditions or issues that would prevent me from safely participating in the Workshop.
- I am not acting against the advice or guidance of my doctor or any medical professional.

## 4. Assumption of Responsibility

I voluntarily assume all risks associated with my participation in the Workshop, including those listed above and detailed in the Workshop Risks Document.

## 5. Release and Waiver of Liability

To the fullest extent permitted by law, I hereby release, waive, and discharge the Company, its directors, employees, agents, and representatives from any and all liability, claims, demands, or causes of action that may arise from my participation in the Workshop.

## 6. Indemnity

I agree to indemnify and hold harmless the Company from any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including legal fees, brought as a result of my involvement in the Workshop and to reimburse them for any such expenses incurred.

## 7. Insurance

I acknowledge that I am responsible for obtaining my own comprehensive travel insurance to cover personal injury, medical expenses, accommodation costs, and loss or damage to personal property, including photographic equipment. I understand that the Company cannot be held liable for any costs incurred due to illness, injury, cancellation, or other unforeseen circumstances, and that it is my responsibility to ensure my insurance policy provides adequate cover.

## 8. Medical Treatment and Emergency Procedures

In the event of a medical emergency, I authorise the Workshop leader, who is first aid trained and carrying a basic first aid kit, to administer necessary first aid. I understand that, in such circumstances, a call for help may be made to the relevant emergency services (999), such as ambulance, police, fire brigade, mountain rescue, coastguard, or lifeboats.

## 9. Compliance with Instructions

I agree to follow all instructions and safety guidelines provided by the Company and the Workshop leader during the Workshop. I confirm that I have read and understood all pre-workshop materials and guidelines provided to me, including the Workshop Risks Document and the Workshop Customer Welcome Pack.

## 10. Entire Agreement

This Agreement constitutes the entire understanding between the parties concerning its subject matter and supersedes all prior discussions, agreements, and representations.

## 11. Severability

If any provision of this Agreement is held to be invalid or unenforceable, all other provisions shall nevertheless continue in full force and effect.

## 12. Governing Law

This Agreement shall be governed by and construed in accordance with the laws applicable in England and Wales.

## 13. Acknowledgement of Understanding

I have read this Liability Waiver and Release Agreement, fully understand its terms, and understand that I am giving up substantial rights, including the right to sue. I acknowledge that I am signing the Agreement freely and voluntarily.
